Important Information:

01. Candidates are advised to collect their **Admit Cards/Roll Number Slips** from the office of the Medical Superintendent, Government District Hospital, Reasi **w. e. f. 12 August 2026 to 17 August 2026** on working days during office hours between **10:00AM to 4:30PM**.
02. The written examination shall be:
 - a. Objective Type (MCQ Based)
 - b. Carrying 50 Marks
 - c. Duration of 01 Hour
 - d. No Negative Marking
03. The syllabus for the examination shall remain confined to the respective academic and professional qualifications prescribed for the advertised post.
04. Typing Test shall be conducted to ascertain the net speed of 35 w.p.m.

Instructions for Candidates:

01. Candidates must report at the examination venue at least one hour before commencement of the examination. No candidate shall be allowed entry after the commencement of examination.
02. Candidates must bring along:
