Terms & conditions:

- The selected candidate shall have to sign a contract with the Medical Superintendent, District Hospital, Reasi as per the guidelines of ATF & NHM.
- Remuneration and leaves whatever kind due shall be applicable as per the guidelines of ATF.
- Initially contract will be up to 31st March, 2027.
- Engagements shall be purely on a contractual basis and shall be non-transferable. The selected candidates shall have to work on the post for which she/he selected. Moreover, selected candidates are directed to submit an affidavit attested by Ist class Magistrate regarding this.
- Contractual appointee shall be required to give one month's prior notice before resigning from the contractual service.
- Contractual appointee shall not be entitled to any preferential claim or right for regular appointment and shall be considered only through the normal process of recruitment/selection as applicable.
- The Medical Superintendent, District Hospital, Reasi, reserves the right, with the approval of the District Health Society, to terminate the appointment of any appointee with immediate effect and without prior notice if the appointee is found to be involved in any unlawful activity, dereliction of duty, misconduct, delinquent behaviour, neglect of duties, refusal to perform, or failure to discharge the duties assigned to him/her.
- Duties assigned to the selected candidates shall be performed as per the scheme/guidelines issued by NDDTC, New Delhi.
- The salary of the selected candidates shall be released only after receipt of satisfactory verification of their documents and antecedents from the concerned institutions and the Police Department.
